Main theme was that sexual crimes are not committed by people because they are rich, athletes or intoxicated, and thus, these behaviors, are not simply a sports issue. The need for proactive sexual assault prevention workshops provided to athletes not because they are more likely to engage in criminal behavior but because they are at-risk due to their popularity.
- April 2006            Did You Get My Yes? A Student-Athlete’s Guide to Sexual Assault - Proactive rape prevention program provided to approximately 250 student-athletes from East Stroudsburg University, educating them about the legalities of sex crimes, the fact that athletes are an at-risk group due to their popularity, and other aspects of prevention specifically tailored to college

student-athletes. Was highlighted in an article written by Dan Berrett and appeared in the 4/5/06 edition of the Pocono Record.

- November 2005      Disciplinary Evaluations for Competence, Responsibility, and the Ability to Tolerate Administrative Segregation in State Prison – Interactive workshop provided to all psychologists employed in New Jersey’s State Prison system who will complete these evaluations for special needs inmates if/when they break institutional rules. Forensic issues included confidentiality, malingering and impact of mental illness on behavior.
- October 2005      Counseling Sessions Create Coping Mechanisms, article written by Jessica Adler and appeared in the October 11, 2005 edition of the Herald News. Dr. Abrams was interviewed to provide readers details of the how-to’s of anger management.
- October 2005      Sexual Violence and Athletes – Lecture given as part of symposium at AAASP’s national conference entitled: Sex and Sexuality Issues in Training and Practice of Applied Sport Psychology chaired by Dr. Judy Van Raalte. Presentation focused on the difficulties in studying the phenomenon, review of different approaches to prevention and recommendations for an ideal prevention strategy.
- September 2005    It’s All Fun & Games Until Someone Gets Hurt – Teaching young athletes how to manage their anger” – Invited speaker for the International Youth Sports Congress – Youth Sports: A New World of Possibilities organized by the National Alliance for Youth Sports. Presentation for 300 worldwide delegates that included Certified Youth Sports Administrators, Police Athletic League directors, YMCA, and other youth sport organizations that outlined the issues related to Codes of Conduct, changing the environment to decrease angry outbursts, and the specifics of anger management skills that could be helpful for parents, coaches, athletes, and officials.
- August 2005      Emotion Management for Peak Performance in Sport – Presentation given to the football team of Dunbar High School in Washington DC as part of the American Psychological Association Division 47’s Sport Psych Give-Away where sport psychologists volunteered to give workshops to teams with minimal resources.
- August 2005      Anger Management in Football – Presentation given to Iona College’s Football Team. Focused on the different forms of aggression and how anger is related to them. Presented the model as both a performance enhancement tool as a means to minimize off-the-field transgressions.
- July 2005      Assessment of Malingering in Correctional Settings – Lecture given to Pre-Doctoral Psychology Interns at Pilgrim Psychiatric Center in West

Brentwood, NY. Gave an overview of formal assessment tools – such as SIRS, MMPI-2 and projectives, but spent more time on the value of time and observing inmates when they do not realize they are being observed. Different issues that increase the probability of malingering such as pending court detainers, the desire to change custody status or housing location, or pending appeals with the goal of change in Judgment of Conviction yielding shorter sentence on the grounds of Not Guilty by Reason of Insanity or Diminished Capacity.

- July 2005 Anger Management for High School and Collegiate Athletes – Presentation given to graduate students at Long Island University/C.W. Post’s Institute for Counseling Student Athletes. Outlined the specific aspects of anger management for this age group as well as the necessary components of successful programming.
- July 2005 Forensic Psychopathology Training for Corrections Officers Working on Specialized Mental Health Units in Prison. Workshop given to Officers and Supervisors who work in Inpatient Psychiatric Units inside Northern State Prison to improve their proficiency in managing the difficult inmate and further their understanding of mental illness. Topics covered include suicide prevention, assessment of dangerousness to self and others, determination of malingering and behavioral control of difficult inmates.
- March - April 2005 Disciplinary Evaluations for Competence, Responsibility, and the Ability to Tolerate Administrative Segregation in State Prison – Interactive workshop provided to all psychologists employed in New Jersey’s State Prison system who will complete these evaluations for special needs inmates if/when they break institutional rules. - March 2005 Anger Management for Young Athletes – Workshop given to coaches, counselors, athletic directors, and sport psychologists at the Summit on Positive Youth Development Through Sport sponsored by the National Football Foundation Center for Youth Development Through Sport at Springfield Conference.
- November 2004 Anger Management May Not Help at All, article written by Benedict Carey for the November 24, 2004 edition of the New York Times. In addition to other experts in the field, Dr. Abrams was interviewed to address the use of anger management skills for athletes following the actions of Ron Artest in which he and other members of the Indiana Pacers conflict with some fans in Detroit.
- October 2004 Best to temper our judgment of angry athletes – Op/Ed printed in The Star Ledger cautioning the assumption that athletes do not have emotional

problems or engage in criminal behavior. The main focus was that it is not their athletic affiliation that causes such problems and they need to have support available to them like other members of society.

- October 2004 SIRIUS Sports Action News Desk – Dr. Abrams was interviewed by hosts Larry Samuels and Mike Yam regarding the psychological factors at work in sports – specifically focusing upon pressure during the Major League Baseball’s Championship Series and recent angry outbursts of baseball players such as Milton Bradley and Jose Guillen.
- October 2004 Anger: How to Moderate Hot Buttons and Reduce Violence in Sport - Chapter written with Dr. Bruce Hale and published in The Sport Psych Handbook edited by Dr. Shane Murphy. It outlines the theoretical framework that anger, and sports emanate from as well as a discussion presenting the intervention options in order to reduce anger in sports to optimize performance in sport and in life.
- September 2004 “Did You Get My Yes?” – Dating Violence Prevention workshop presented for the Metro Atlantic Athletic Conference’s (MAAC) Student Athlete Advisory Committee. Presentation was funded by the NCAA Speakers Grant, and it highlighted legal as well as psychological issues related to dating violence on the college campus. The audience consisted of representative student athlete advisors from all of the participating MAAC universities.

Information was both didactic and interactively presented and spanned the gamut from definitions and theories to assessment and interventions.
- July 2004 Anger Management for Athletes – The Nuts & Bolts - Presentation given to counselors, coaches and teachers at Summer Institute for Counseling the Student Athlete sponsored by Long Island University – Rockland Campus.

Program focused on the development of new definitions, overview of related theory, and explanation of the need for and “how to” of implementation of anger management programs for student athletes to facilitate peak performance in sport and in life. Dating violence prevention and substance abuse issues were covered as well.

- May 2004                    Anger Management – A Means to Success in Sport and Life. A– colloquium presented to a combined audience of the Clinical Psychology and Athletics Departments at Fairleigh Dickinson University. Introduced research in the field of athletes and violence as well as dispelling the Myth of the Violent Athlete. Outlined the basic components of an anger management program for athletes as well as specific issues related to the athlete population.
- April 2004 – 2020        Healthy Relationships – Interactive presentation given annually to seven health classes of male and female seniors at Millburn High School, in preparation for their graduation, focusing on the aspects of healthy relationships including respect, mutuality, communication and independence. Issues related to dating violence and abusive relationships were covered as well but not as the primary focus.
- February 2004            Forensic Psychopathology Training for Corrections Officers Working on Specialized Mental Health Units in Prison. Workshop given to Officers and Supervisors who work in Inpatient Psychiatric Units inside Northern State Prison to improve their proficiency in managing the difficult inmate and further their understanding of mental illness. Topics covered include suicide prevention, assessment of dangerousness to self and others, determination of malingering and behavioral control of difficult inmates.
- October 2003             Advanced Psychopathology for Sport Psychologists – What You Need to Know. Colloquium presented at AAASP’s Annual Conference addressing diagnostic factors needed to identify athlete psychopathology. Highlighted assessment and interventions for psychiatric emergencies: suicidality and psychosis; as well as other dangerous pitfalls that can emanate from a trauma history or character disorders.
- October 2003             Anger Management for Athletes – The Nuts and Bolts. This six-hour workshop geared toward sport psychologists from the psychology and sport science field was a C.E. program sponsored by AAASP. Offered comprehensive information regarding research and theory associated with violence and sports as well as illustration of necessary components of effective programs to be delivered to athletes to optimize peak performance in sport and in life. In addition, dating violence prevention material was included as ancillary, related work.

Post – Brentwood Campus. Program focused on the theory, need and implementation of anger management programs for student athletes to facilitate peak performance in sport and in life. Dating violence prevention and substance abuse issues were covered as well.

all levels of mental health staff (inpatient, outpatient, gang unit, administrative segregation) at Northern State Prison identifying the symptomatic sequelae of trauma-related syndromes for diagnostic and intervention purposes. Provided guidelines for differential diagnosis of borderline personality disorder and PTSD as well as introduction of novel therapeutic techniques in a correctional setting.

Presentation given to counselors, coaches, teachers, and graduate students at the above titled summer institute offered by Long Island University's C.W. Post Campus. Also presented as part of this symposium: Anger Management: Successes & Failures on an Inpatient Psychiatric Ward

- June 2001 Athletes and Dating Violence - "Did You Get My 'Yes'?" Workshop given at The Eighteenth Annual Conference on Counseling Athletes at Springfield College. Discussed the development of a multi-tiered proactive program to prevent dating violence among athletes. Focused upon incidence rates, legal statute, myths, and analysis of current programs. Highlighted clinical issues, anger management, substance abuse and male athletic culture as targets for interventions.
- June 2001 Corrections Officers' Role in the Treatment of Psychiatric Inmates. Presentation given to Lieutenants, Sergeants and Corrections Officers at Northern State Prison in Newark, NJ working with Special Needs inmates. Focused upon forensic psychopathology, diagnostic issues, medication management, assessment & interventions with clinically unstable inmates and coordination of custody and mental health personnel around such crises.
- October 2000 Anger Management as a Necessary Part of Coping. Presentation given at the Association for the Advancement of Applied Sport Psychology (AAASP's) national convention in Nashville, TN. Program focused on the specifics of anger management and how it fits in a coping model.
- August 2000 Managing Your Anger to Discipline Your Children Effectively. Workshop given at Hewlett-Woodmere Public Library to parents, grandparents and educators focused on how anger interferes with effective discipline and provided skills training to modulate this emotion.

Inservice workshop given to staff of Coney Island Hospital teaching the theoretical underpinnings, history, and crucial elements of anger management services. Recognizing the detrimental effects hyper-arousal associated with anger has on performance, anger management skills were offered as a means to reduce this affect state. Recognition of physiological sequelae associated with anger, relaxation techniques, identification of triggers, problem solving, and consequence prediction were presented as necessary skills for athletes to facilitate optimal performance.

Inservice training provided to psychologists, social workers, nurses, and counselors who comprise the therapeutic staff of Coney Island Hospital's Comprehensive Drug Addiction Treatment Program (CDATP). Emphasizing the incidence of anger disorders in MICA populations, skills were offered to reduce interpersonal violence. Relaxation exercises provide self-soothing mechanisms to be substituted for self-medicating. Cognitive distortions often found in substance abusers were addressed and reframing alternatives provided.
- February 1999      Facilitating Athletic Success through Focused Aggression Training. Workshop given to athletes, coaches and support staff at Iona College focusing on the need to identify the different types of aggression and reducing the forms that interfere with optimal performance. Emotion labeling, anger management and imagery are discussed as methods to meet athletic goals.
- October 1998      Anger Management and Sports: How It Helps You Reach Your Goals. Interactive presentation given to the men's and women's basketball team, as well as the men's soccer team at Passaic County Community College. Focused on the need to control emotions to elicit peak performance. Provided skills training to assist athletes in reaching performance goals. Examples of professional athletes who utilize such techniques facilitated skills acquisition.
- August 1998      Violence Reduction Via Anger Management for Male Athletes. Poster session presented at the APA's Annual Convention. Focused on the necessity of a prosocial, preventative program to provide athletes with skills to prevent conflict. - March 1998      Parents of Athletes: Help Your Kids Become Real Winners - Margaret Basner Parenting Center of Tempo Group - Interactive lecture on issues such as: teamwork, competition/losing, modeling, living vicariously through one’s children, the importance of athletics being balanced with academics, how society treats athletes, and learning to recognize and deal with anger, anxiety, and depression associated with sports.
- Feb - March 1998      Anger Management Training - Nassau County Youth Board - Training for Caucus Members - Provide Anger Management & Conflict Resolution Training for 40 high school students who are being trained at Nassau Community College to become Caucus Members to the Youth Board.
- Feb - March 1998      Anger Management for Coaches - Mid-Island Y Jewish Community Center - Workshop over two sessions (one hour each) that introduced the basic tenets of anger management to coaches to communicate more effectively with their players and model how to cope with frustration. Also, a primer for similar workshops was directed to athletes and their parents.
- Feb - March 1998      How to Manage Anger & Discipline Your Children - Mid-Island Y Jewish Community Center - 2-part 4-hour workshop for parents of children aged 2 - 10. Focused on methods of controlling parents’ anger related to frustration with parenting. Techniques to de-escalate parental arousal were presented to provide more effective disciplining.
- January 1998      Keeping Your Anger Under Wraps: Emotional Control Leads to Performance Enhancement. Article written for Muscle & Fitness magazine and appeared in November 1998 issue. Delineated the reasons for anger management as related to weight training and meeting health and fitness goals. Presented a “how-to” model of reducing unfocused anger to enhance performance in the gym and out.

- December 1997 In Sports: Winning Isn't Everything by Jay Jaffe appeared in the December 11-17, 1997 edition of the Nassau Herald. Article which described the application of the Anger Management program to the Hewlett High School Basketball Team. Was interviewed for the specifics of the curriculum.
